

# Acceptable Proofs Document

## Acceptable Proof of Identity and Residence

If you have been asked to send in further proof of identification and/or residence, please refer to the information below for guidance on documents that we can accept.

Please note that all documents must show your full name, be currently valid, and be the most recent available. You cannot use the same document for proof of identity and residency.

Please send one document from list A to confirm identity and one document from List B to confirm address.

A: Proof of Identification

Current Passport	Be currently valid

	Be a clear copy with photo clearly visible
Current UK/Northern Ireland	Full or provisional
Photo Driving License	Be currently valid
	<ul> <li>Include full name, date of birth and photo</li> </ul>
	Be registered at current residential address
	Both sides of the document must be provided
National ID card (non-UK	Be currently valid
nationals)	Issued by Government
	<ul> <li>Include full name, date of birth and photo</li> </ul>
	Both sides of the document must be provided
	For non-UK passports, or EU identity cards, please also supply
	evidence of settlement status (indefinite leave to remain)

B: Proof of Address (*if not already used for identity)		
Document	Documents Must:	
Current UK/Northern Ireland	Full or provisional	
Photo Driving License*	Be currently valid	
	<ul> <li>Include full name, date of birth and photo</li> </ul>	
	Be registered at current residential address	
	Both sides of the document must be provided	
Utility Bill	Be a Gas, Electricity, Water or Landline Phone Bill (not)	
	Mobile)	
	<ul> <li>Include full name and current residential address</li> </ul>	
	Be dated within the last 3 months	
	Be a full statement	
Council Tax Bill	<ul> <li>Include full name and current residential address</li> </ul>	
	Relate to the residential address	
	Be dated within and relevant to current tax year	
Bank/Building Society Statement	<ul> <li>Include full name and current residential address</li> </ul>	
or Credit Card Statement	Be dated within the last 3 months	

HMRC Tax Notifications or	Include full name, current residential address and
Awards Letter	National Insurance Number or date of birth
	Be dated within the current tax year
	A P45/P60 is not acceptable
State Pension or Benefits	Include full name, current residential address and
Book/Notification Letter	National Insurance Number or date of birth
	Be dated within the current tax year
Mortgage Annual Statement	Include full name and current residential address
	Be the most recent statement dated within the last 12
	months
	Be from a recognised lender

### Acceptable Proof of Ownership (for Nominated Account)

If you have been asked to send further proof to confirm your nominated bank account, please refer to the information below for guidance.

To confirm your nominated account belongs to you, we require a recent bank statement showing your details.

#### Your bank statement must:

- Show your full name (first name and second name)
- Show your sort code and account number
- Be dated within the last 3 months
- Show activity during this period
- Not have a zero balance or be a closed account

#### **Next Steps:**
